



SESSION DETAILS: Please remember to be prompt when arriving for your scheduled time. Your session time starts at your scheduled time, not when you're ready so let's maximize our time together. Sessions might be scheduled back to back and far ahead of time, so again, please be courteous and aware of our timeline together!

EDITING & AVAILABILITY: Photographs should be edited and returned to you within two to three weeks of your originally scheduled session. Edited photographs will be housed in an online gallery that is account protected. Don't worry, I will send you an email with the link to your specific photo gallery. Each client will have their own gallery. Anyone, friends or family, that you share the link with can access your gallery. Edited photographs are downloadable. Simply download to your computer and can be freely used. I go through an extensive editing process and culling your gallery is something I take pride in. I give you the most beautiful images from our time together- this may include a posed or candid moment, a detail shot etc.

PAYMENT: Payment (session) fees are all based on session time, amount of people and event being photographed. We will confirm payment fees at time of session booking. A session hold deposit fee of \$25 is required for all sessions and is due at the time of booking. At time of session you would owe the remaining balance of the session fee. I will not have change on me so please bring exact amount owed. Cash is preferred. Tip is appreciated, but not required. If you loved your experience, let me know!

EXHIBITION: Client grants Katrina Baker permission to display selected images as an example of Katrina Shiree Photography's portfolio and for entrance into photographic competitions and release all claims to profits that may arise from use of images.

MODEL RELEASE: The client hereby grants to Katrina Baker and its legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of the client or in which the client may be included, for editorial, trade, advertising and any other purpose in any manner and medium; to alter the same without restriction; and to copyright the same. The client hereby releases Katrina Baker and its legal representatives and assigned from all claims and liability to said photographs.

LIMIT OF LIABILITY: Katrina Baker takes the utmost care with respect to exposure, transportation, and processing of photographs. However, in the unlikely event that photographs have been lost, stolen, or destroyed for reasons within or beyond Katrina Baker's control, Katrina Baker's liability is limited to the return of all payments received for the event. The limit of liability for a partial loss of originals shall be prorated amount of the exposures lost based on the percentage of total number of originals.

RETAINER: In the event of cancellation, the session hold deposit fee is non-refundable and upon re-scheduling of the session a new deposit will be required.
